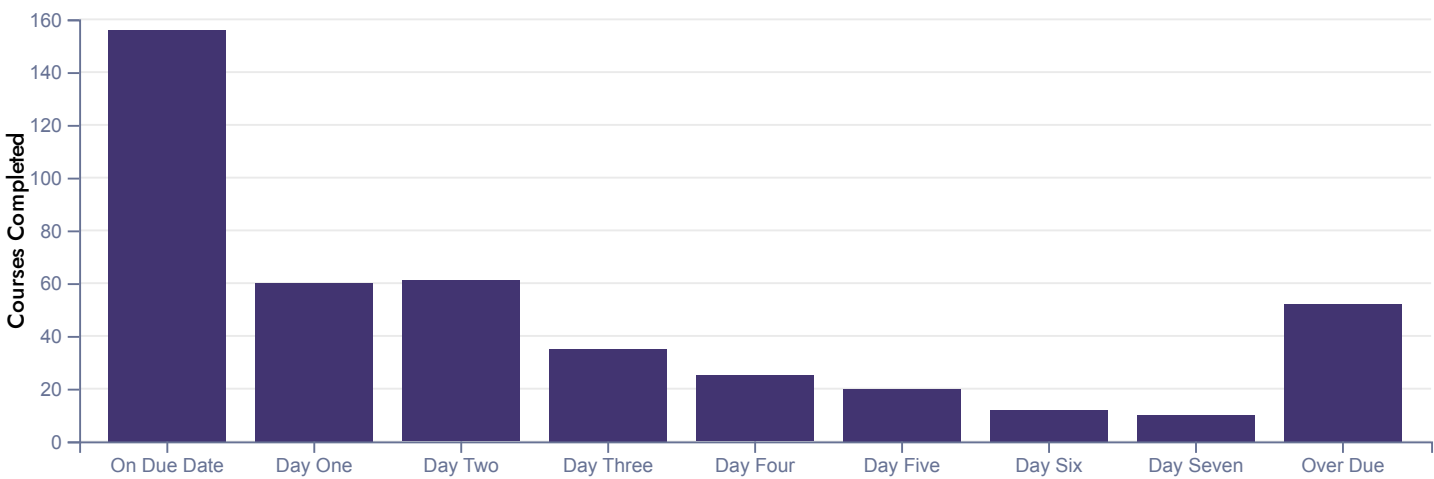

Training Engagement via Due Date

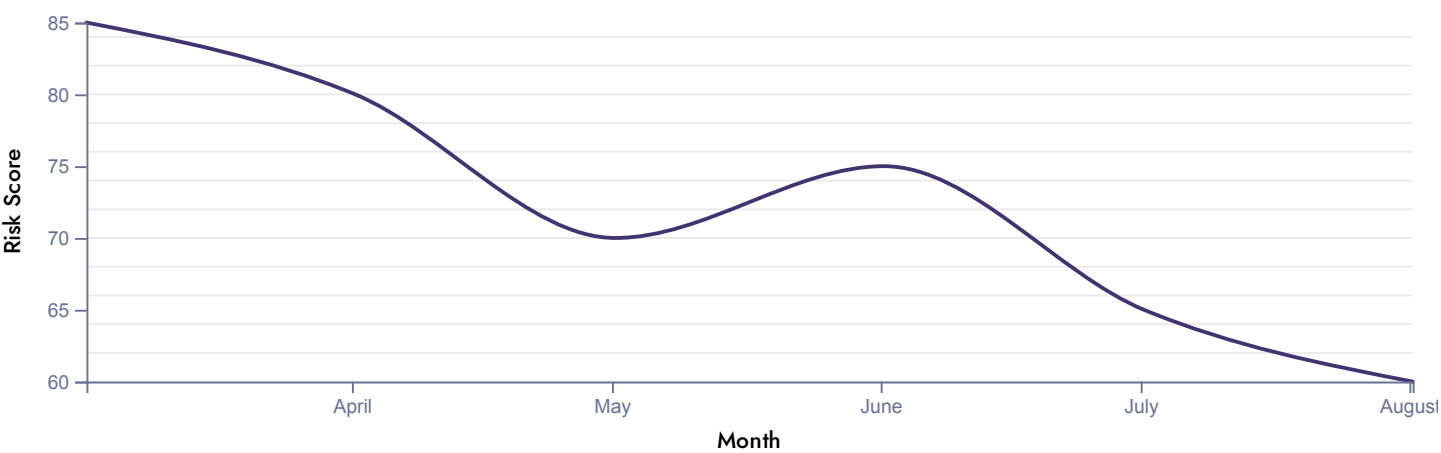
The graph shows the average days taken to complete a course last month. Courses are due on the day assigned, with a seven-day grace period before being overdue.

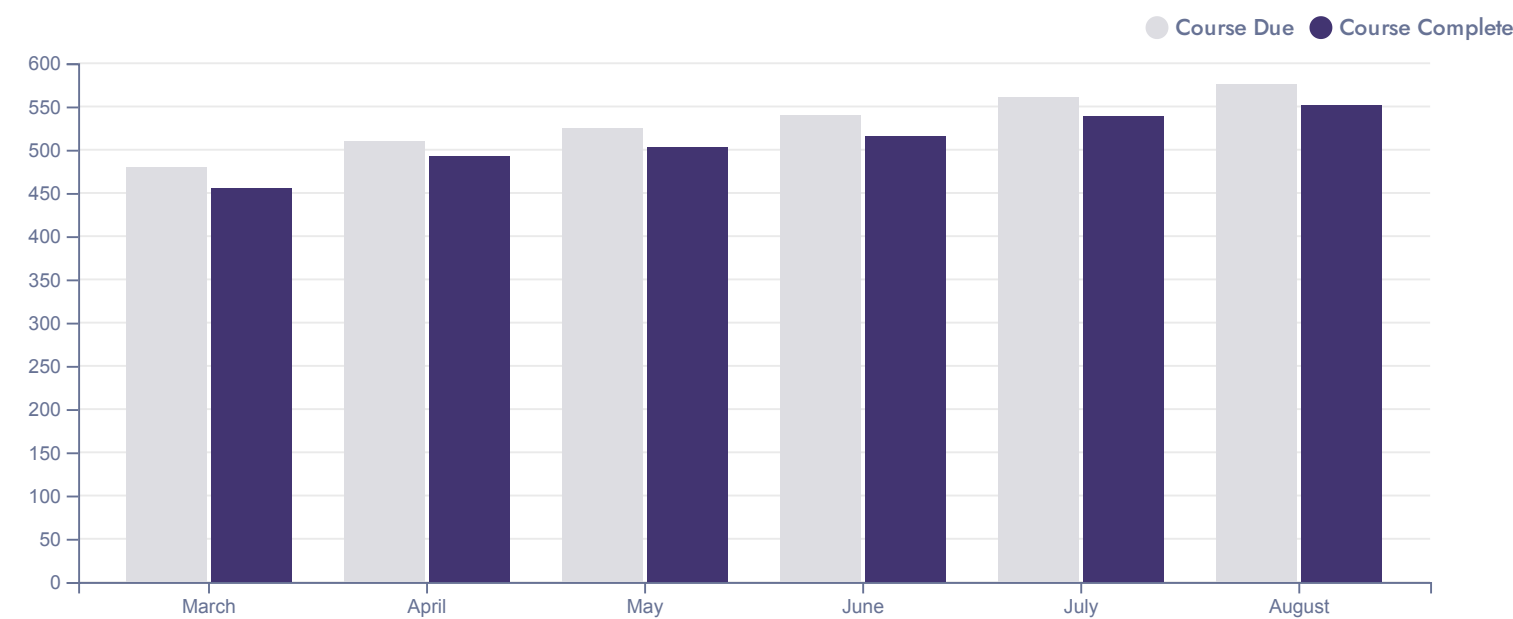

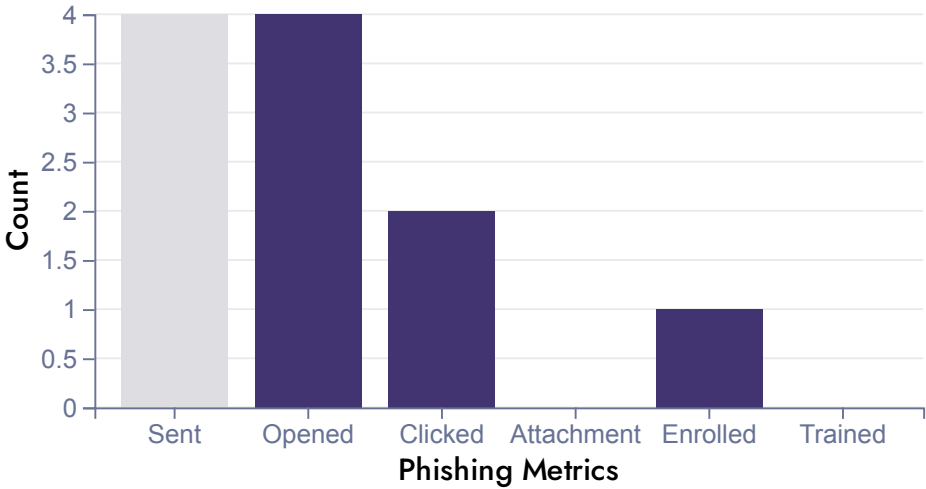
